1. About Government College Bharmour

Govt. College Bharmour was established in 2005, vide Government Notification No. EDN-A Kha (16) dated August 3, 2005. The college offers undergraduate programs, namely Bachelor of Arts, Bachelor of Commerce, and B.Sc. in Non-Medical. It is affiliated with Himachal Pradesh University, Shimla, and serves as an examination centre for the university.

The college is situated near the renowned Chaurasi (84) temple complex in Bharmour town – a historically significant and picturesque valley in Chamba District, Himachal Pradesh. It is surrounded by a panorama of snow-capped mountains and flanked by the Budhil River. Bharmour derives its name from the historic Brahmapur Kingdom and served as its capital before the administration was shifted to Chamba. The college recently shifted to its new building at Helipad Bharmour. It offers many facilities to enhance the teaching-learning environment, including:

- **Modern Open Public Library:** With a seating capacity of more than 150 students
- **Digital Library:** Equipped with 20 reading tablets
- **Computer Lab:** Featuring 15 computers
- **Conference Hall:** With a seating capacity of 100 students.
- **Virtual and Smart Classrooms:** Equipped with a 100 mbps lease line and Wi-Fi
- **Multipurpose Hall:** For cultural activities with seating capacity of 500 students
- **Gym and Kabaddi Mat:** For sports activities
- **CCTV Surveillance:-** 30 CCTV Caners are installed for surveillance
- **Faculty:-**All teaching posts are filled with young and dynamic faculty
- **Proper Seating Space:** With airport sofas and public benches for students.

3. Eligibility Conditions for UG Degree Programs

- A student must have passed the Senior Secondary (+2) Examination (In any academic stream) conducted by the H.P. Board of School Education or an examination accepted as equivalent thereto by the various bodies of the by the various bodies of Himachal Pradesh University.
- Provided that a student who has qualified in the examination with a science stream, commerce, or arts shall be given preference in admission to their respective stream.
- Merit will be worked out by taking into consideration the best of five subjects, including English as one of the subjects.
- The roster for reservation of seats for various categories shall be as per rules of H.P.U.

Class	Minimum Percentage of marks required in 12th
B.A. 1 st Year	33% marks in aggregate, including all the subjects
B.A. with Maths	45% marks in aggregate or in Mathematics
B.Sc. 1 st Year	45% marks in aggregate in five subjects, including English with Physics, Chemistry and Mathematics
B.Com 1 st Year	45% marks in aggregate with Mathematics/Economics as compulsory subjects or 40% marks with Commerce and 33% marks for girls

As per the direction of the Hon'ble High Court, any candidate with compartment in 10+2 will not be eligible for seeking admission in undergraduate courses.

4. Upper Age Limit for UG Degree Programs

- The maximum age limit for admission to the 1st Year of UG Degree Programs is 25 years for girls and 23 years for boys, as on July 1, 2025.
- The Vice-Chancellor, HPU, may, in exceptional cases/circumstances to be recorded in writing, grant a relaxation in age of up to a maximum of six months to any candidate. All such cases of age relaxation of up to six months may be granted admission provisionally by the Principal, and a consolidated list of all such cases will be sent for the approval of the Vice-Chancellor by October 31 of every academic year.

Relaxation in the upper age limit is also admissible to physically challenged candidates.

5. Procedure for Admission in UG Classes

New candidates must register and apply through the Online Admission Portal at <https://gcbharmour.highaltdeducation.in/> before the last date. All applicants have to register on the ABC portal and create their APAAR ID. Before filling the admission form, candidates must have scanned copies of following documents.

1. An active self-email ID and a valid mobile number.
2. Email ID is necessary to activate a candidate's registration. The system permits an email ID to be registered only once.
3. Aadhaar Card
4. Recent passport-size photograph and signature.
5. Detailed Marks Card of the previous passed examination (Matric and 12th class).
6. Certificate of caste and category (for SC/ST).
7. Character certificate from the institution last attended.
8. Gap certificate for dropout students.
9. Candidates from other Boards/Universities must submit the following in the College:
 - Eligibility certificate from H.P. Board/University showing equivalence
 - Migration Certificate.
10. All girl candidates have to upload a scanned/soft copy of the Bonafide Himachal Certificate for getting exemption from tuition fees.

Note

The email ID and mobile number must belong to the candidate himself/herself or someone in the family. DO NOT fill in friends' or Cyber Cafés email IDs and mobile numbers. Please keep your email ID and mobile number active, at least until the admission process is complete, as all communication will be sent through email/SMS. It is advised to regularly check email, SMS, and visit the College website for the latest updates on the admission process.

6. General Rules for Admission

1. Admission will be made on the recommendation of the Admission Committee.
2. Admission will be strictly granted only upon fulfilment of all eligibility conditions.
3. All admissions will be provisional, subject to final approval by Himachal Pradesh University, Shimla.
4. The college reserves the right to modify admission terms, conditions, and fee structure as per directives from Himachal Pradesh University, Shimla.
5. Applicants must upload scanned copies of original certificates on the admission portal.
6. Applicants with a gap of one or more years in their academic history must submit an undertaking.
7. All students seeking admission must pay ₹500 annually towards the PTA fund. Note that all fees and funds are non-refundable once deposited.
8. Female students must upload a scanned/soft copy of their H.P. Bonafide certificate to avail tuition fee concessions.
9. Students claiming fee exemption due to disability must upload a scanned/soft copy of their 40% disability certificate.
10. For students seeking admission to TDC II or TDC III based on qualifications from universities other than HPU/SPU Mandi, admission will be regularized only after syllabus equivalence is confirmed by the respective university.
11. Candidates from education boards/universities other than HP Board/HPU/SPU Mandi must submit a migration certificate copy to the college.
12. The admission of a student is liable to be cancelled in case he/she furnishes incomplete, wrong, or false information, or in case of concealment of facts. Disciplinary action will also be taken against such a candidate.
13. A student who has been expelled or rusticated shall not be admitted to any course of study without the prior approval of the Vice-Chancellor.
14. Students who have passed after re-evaluation shall not be considered for admission/promotion to the higher class after the expiry of the scheduled date of admission as per the rule framed under Ordinance 6.70(e) H.P.U. vide letter No. 4-19/2003-H.P.U. (Acad) dated January 24, 2003.

7. Steps to Fill the Admission Form

(i) For B.A. /B.Sc. /B. Com – 1st Year

1. Online Admission Process

4. Application Process

- Select "Click Here to Apply" for your desired course

5. Form Completion

- Fill all required fields in the application form
- Upload:

 - * Required documents
- Click "SAVE AND NEXT" after each section
- Review and edit information before final submission

6. Payment Process

- Click "SUBMIT AND PAY PROSPECTUS PAYMENT"
- Pay ₹50 online via:
 - * Debit/Credit card
 - * Net banking
- Save the payment receipt

7. Document Verification

- Attend in-person counselling with original documents
- Bring documents on specified date and time

8. Application Review

- College will verify uploaded documents
- You will receive SMS/email about any deficiencies
- Correct deficiencies promptly

9. Admission Confirmation

- Eligible candidates will receive admission confirmation via SMS/email
- Pay fees ONLINE within stipulated time
- Print and submit application form with document copies

10. Important Notes

- Failure to pay fees by deadline will result in seat forfeiture
- Next eligible candidate will be considered
- Check SMS/email and notice board for: roll no., time-table etc.

(ii) For B.A. /B.Sc. /B. Com – 2nd and 3rd Year

Admission to the 2nd and 3rd year undergraduate courses will be made on a roll basis, according to the orders issued by the Directorate of Higher Education, Shimla, from time to time. Students seeking admission to a higher class should have completed the previous class and appeared for the examination. Students are required to submit the necessary fees after uploading the following documents.

- Upload the admit card from your previous examination
- Upload the grade card from your previous class.

9. National Education Policy (NEP) 2020 For UG First Semester

In pursuance of the Notification No. EDUA-009/7/2025-278440-NEP dated April 1, 2026 issued by the Department of Higher Education, Govt. of Himachal Pradesh and Letter No. 7-1/2025-HPU (Acad) dated April 18, 2026 issued by the Himachal Pradesh University, Shimla, the Government College Bharmour shall implement the National Education Policy (NEP) 2020 for all students admitted to the 1st Semester from the academic session 2026–27 onwards. The NEP framework envisages a holistic, student-centric and multidisciplinary approach to higher education with emphasis on flexibility, skill enhancement and multiple entry and exit provisions.

► Key Features of NEP-2020 Framework

- Multiple Entry & Exit Options
- Choice-Based Credit System (CBCS)
- Multidisciplinary Learning Approach
- Skill-Oriented & Employability-Focused Courses
- Integration of Internship/Apprenticeship/Community Engagement
- Emphasis on Holistic & Value-Based Education

► Programme Pathways

After semester II a student may opt for:

- Single Major Programme
- Multidisciplinary/Interdisciplinary Programme

Note: Once chosen, the Major/Minor combination continues till Semester VI.

► Important Academic Guidelines

- Students study three subjects (A, B, C) in Semester I.
- Minor subjects are derived from initial disciplines studied.
- Multidisciplinary Courses (MDCs) must be from outside Major/Minor disciplines.
- Skill Courses (SEC) include both discipline-specific and open options.
- Language Courses: Maximum two allowed as Core/Minor.
- Internship (IAPC) is introduced early for practical exposure.

These guidelines ensure flexibility with academic depth.

► Progression to 4-Year Honours Degree

Students securing 75% or above up to Semester VI may opt for the 4-Year Honours Degree (subject to university approval)

Bachelor Courses under NEP 2020 (*Only for 1st semester students*)

1. B.A. (Economics, English, Geography, Hindi, History, Political Science)
2. B.Com.
3. B. Sc. Physical Sciences: (Physics, Mathematics and Chemistry)

10. Structure of Courses under NEP 2020 (Offered in Semester I and II only)

- 1. Core Course:** A course which should compulsorily be studied by a student as a core requirement is termed as a Core course. Two Discipline Specific Core (DSC) Courses of two different subjects will be taught in both the semesters to the students. The course designed for papers under this category aims to cover the basics that a student is expected to imbibe in that particular discipline.
 - In Semester I and II, students have to study DSC courses of their chosen Major discipline.
 - These courses are compulsory and form the foundation for advanced learning in subsequent semesters.
 - Each DSC course will be of 4 credits.
- 2. Minor Course (MC):** Minor Courses are taken from a discipline other than the Major. These courses enable students to gain additional knowledge and develop competency in a secondary area of interest. A student has to study one minor course also in each semester from a pool of minor courses available to him/her.
 - In Semester I and II, students opt for one Minor subject and study its courses alongside the Major.
 - Each minor course will be of 4 credits.
- 3. Multi-disciplinary Course (MDC):** Multidisciplinary Courses are designed to provide exposure to disciplines other than the student's Major and Minor subjects. These courses promote broad-based learning and interdisciplinary understanding. A student has to study one multidisciplinary course also in each semester from a pool of such courses available to him/her. MDC will be different from Discipline Specific Core courses and Minor courses and student must not have studied that course at 12th level. Each MDC will be of 3 credits.
- 4. Skill Enhancement Course (SEC):** Skill Enhancement Courses of each subject aim at developing practical and technical skills related to that subject. A student has to study one SEC in semester I and II from the offered subjects. Each SEC will be of 3 credits.
- 5. Ability Enhancement Course (AEC):** Ability Enhancement Courses are aimed at improving language proficiency, communication skills and foundational competencies. A student has to study one AEC in semester I from the pool of ability enhancement courses provided by the college. An AEC will be of 2 credits.
- 6. Internship / Apprenticeship / Project / Community Outreach (I/A/P/C):** This component is designed to provide experiential learning through internships, apprenticeships, project work or community engagement. It helps students apply theoretical knowledge in real-life situations and enhances their employability chances, practical exposure and social responsibility. A student has to compulsorily do any one out of

internship, apprenticeship, project or community outreach at the end of second semester. This will be of 4 credits.

7. **Value Added Course (VAC):** Value Added Courses are introduced to impart value-based education and holistic development. A student has to study one VAC in semester II. These courses may include areas such as ethics, human values, digital awareness, health, or environmental consciousness. It will be of 2 credits.

2. For B.Com first year just select the B.Com stream and For B.Sc. Physical Science (Non-Medical) just select Math, Physics and Chemistry
3. At the end of the second semester, each student may choose one of two programmes: the Multi-Disciplinary/Interdisciplinary or Single Core Discipline (Major) programme. The student choosing the latter will be required to give his/her Major and Minor at the end of the second semester. Such choices, including DSCs made at the end of the second semester, shall remain in effect until the VI semester. The prescribed credit weightage includes Lecture, Tutorial, and Practical components.
4. The DSCs of another discipline for the first two semesters of students who opted for Major programmes will be treated as Minors.
5. A DSC offered in one discipline will be treated as a Minor by another. Students can choose Minor Courses from two different subjects, but must earn a minimum of 12 credits in each.
6. MDCs must be selected from a broad discipline/pool of MDCs other than Major and Minor disciplines/subjects and must not have studied that course at the 12th level.
7. AEC/VAC/SEC-3 should be chosen from a pool of courses. Every discipline shall provide these courses, some of which will be offered discipline-specific, while the rest can be open to students of all other disciplines. However, the two SECs (SEC-1 & SEC-2) must be chosen from the discipline-specific (Core and Minor).
8. A maximum of two language courses can be opted for as Core and Minor. AECs should be in a language other than what is studied in DSCs/Minors.
9. I/A/P/C will be determined at the end of the first semester to enable students to carry out some I/A/P/C activities during winter vacation.
10. To pursue an Honours & Honours with research in the 4th year, students shall study one discipline in which s/he has studied at least 11 core courses (6 DSCs + 5 DSEs) in the first three years.
11. A student who secures 75% or more marks in aggregate till semester 6 (up to a 3-year degree) shall be eligible for a 4-year degree Honours with Research, provided HPU has approved the college to offer it.
12. One course per semester (DSC/Minor/MDC/SEC/etc) from a subject offered in two (or more) different programs (e.g. BCA and BSc/ BPA and BA/ BFA and BA/ Shastri and BA/etc) must be the same.
13. Students in the BA programmes can opt for only one DSC each from the Bachelor of Performing Arts (Dance, Music, Vocal & Instrument/Tabla/ etc.) and the Bachelor of Fine Arts (Painting/Applied Arts/Sculpture/ etc.).

14. Major and minor shall be awarded on fulfilment of the following conditions:

For Major, 64 credits in a 3-year & 84 credits in a 4-year UG programme in a single Major Discipline.

For Minor, 28 credits in 4-year UG programme in a single Minor Discipline.

**As this scheme is being introduced for the first time, it is subject to modifications. Any changes applied in subsequent years after admission to the 1st Year will be retrospectively applicable.*

12. Choice-Based Credit System for 2nd and 3rd year Students

The **Choice-Based Credit System (CBCS)**, introduced under the **Rashtriya Uchhatar Siksha Abhiyan (RUSA)**, was adopted for undergraduate courses in 2013-14. This system aligns with the guidelines issued by the Government of Himachal Pradesh and is amended periodically. The present annual CBCS system offers; **Core Courses, Skill Enhancement Courses and Ability Enhancement Courses**. CBCS is based on the Continuous and Comprehensive Evaluation consisting of Internal Assessment (Mid-term Test, Assignment and Attendance), Practical and Term-end Examinations as per detail shown in following table.

Students are required to **earn 44 credits annually**, totaling **132 credits** for a pass course (B.A./B.Sc./B.Com). This total includes:

- **72 credits** for Core Courses (DSC)
- **24 credits** for AECC + SEC

- **36 credits** for Discipline Specific Elective (DSE) and Generic Elective Course (GEC)

It's important to note that the **SEC will be from DSC-I**, and the **GEC must be other than DSC**. Different course combinations and their respective credits are shown in the table below. The nomenclature for different courses is as follows:

18. Fee Concessions and Scholarships

- Students belonging to **SC/ST, OBC, IRDP families**, and those eligible under the **Poverty-cum-Brilliance** category (whose parents are bona fide residents of Himachal Pradesh) are entitled to scholarships under government schemes.
- As per Government Notification No. EDNH(8)7/76 dated 29/06/2001, **all girl students of Himachal Pradesh** are eligible for full fee concession. A duly attested bona fide Himachali certificate (by a Revenue Officer) must be submitted to the college office.
- Students with disabilities (PWD)** are entitled to both full fee concession and scholarships.
- According to UGC Letter No. F.127/2009, all eligible **SC/ST, OBC, and PWD** students must submit their scholarship forms by **February** each academic year.
- A student can **avail only one scholarship** in an academic year.
- In case of multiple siblings studying in the college, **only one sibling** (the one in the **lower class**) is eligible for **half fee concession**.
- Dr. Sukhpal Singh Memorial Award:** A cash prize of **₹2500** is awarded annually to the **final year/semester university topper girl student**.

19. Fees and Funds

- Fees must be deposited at the time of admission.
- Fines and other dues, if any, shall be collected in the month of March.
- College fees and other charges must be paid as per the schedule notified by the college office. Failure to do so will result in a fine.
- If a student fails to pay the required fee or fine by the end of the scheduled month, his/her name will be struck off the college rolls.
- Library security will lapse if not claimed within one year of leaving the college.

Note: Fee once deposited will not be refunded under any circumstance

In today's globalized job market, there is a growing demand for vocationally and professionally oriented Add-on programs alongside traditional graduation degrees. Keeping this requirement in view, the University Grants Commission (UGC) introduced regulations in the 1990s to prepare Indian

universities and affiliated colleges for such programs. This initiative aimed to vocationalize and professionalize undergraduate education during the Eighth and Ninth Five-Year Plans (1992–97 and 1997–2002). As a result, many professional and vocational institutions were established within existing universities and their constituent colleges, offering vocationally oriented courses and curricula.

With this vision, the UGC restructured the vocationalization program at the undergraduate level under a modified scheme known as the **Career-Oriented Program** during the Tenth Plan period. These new programs were designed to be flexible, offering certificate, diploma, and advanced diploma courses that would run parallel to conventional undergraduate and graduate degrees. The initiative was also driven by the understanding that “administrative” government jobs would decline over time, while economic liberalization would increase employment opportunities in the private sector.

In line with this vision, **Government Degree College Bharmour** offers a range of *Add-on* programs, which will be announced during regular classes. These courses will be conducted beyond the routine timetable of the college.

21. Rules for Students

A. Academic Assessment Rules:

It is compulsory to fulfill the required lecture attendance. Students will be allowed to appear in the end-term examinations only if they have passed the **Continuous Comprehensive Assessment (CCA)** and met the house test conditions laid down by the University. If a student fails to fulfill any of these conditions, they will not be allowed to sit for the examination, as per Resolution No. 22 of the Academic Council of Himachal Pradesh University. It is essential for all students to take the class tests given by the subject teacher from time to time, in addition to the House Examinations held by the College and notified at the proper time. The internal assessment will be of 30 marks (Mid-Term Test: 15 marks, Assignments/Seminars/Tutorials: 10 marks and Attendance: 5 marks)

Condition: Only those students who pass the CCA, as per HPU Note 1 of Ordinance 7.10(D) dated March 14, 2018, will be allowed to appear in the End-Term Examinations.

B. Conduct and Discipline

The Principal can impose a fine, suspension, or expulsion on any student found indulging in misconduct as listed below. **Violation of discipline on campus will not be tolerated at all.**

1. Apart from ragging, other serious offenses include:
 - Writing obscenities or offensive words on blackboards, walls, or furniture.
 - Aimlessly loitering in the verandahs, creating noise, or attempting to disturb classes.

- Smoking or consuming drugs/alcohol etc., on the college campus.
 - Any attempt to damage furniture or any property on the campus.
 - Bringing unauthorized outside elements/persons to the campus or sitting unnecessarily within the campus.
 - Playing in the ground without the Principal's permission.
 - Pasting posters on the walls or the Notice Board without the Principal's permission.
2. Students who participate in sports or other extracurricular activities/educational tours must produce written permission from their parents/guardians.

Every student must always carry their identity card, which is issued upon joining the college. They must produce their Identity Card whenever demanded.

Parents/guardians are requested to remain in touch with the Principal and concerned teachers regarding the progress of their wards in the college.

C. Rules for Leave

Leave will be granted only on the prescribed leave application form available in the college office.

1. The leave form must be signed by the student's parent or guardian and duly recommended by the class tutor.
2. A tutor can sanction leave for up to **6 days**. For leave exceeding this period, the application must be approved by the **Principal**.
3. Students are permitted a maximum of 10 days of leave in an academic year.
4. **No leave will be granted during Minor Tests**. Leave during House Examinations or Class Tests will be sanctioned by the Principal in **exceptional cases only**.
5. Students participating in inter-college games, youth festivals, or other competitions must get their leave sanctioned by the Principal and noted by subject teachers concerned before departure.
6. In case of **illness lasting more than 10 days**, the leave application must be accompanied by a **medical certificate or hospital registration slip**.
7. Leave due to sickness must always be supported by a valid medical certificate.
8. If a student remains absent **continuously for more than 7 days without sanctioned leave**, their name will be **struck off** the college rolls.
9. Re-admission in such cases must be sought within 10 days of the date on which the name is struck off (as notified on the college notice board). A written application with the tutor's recommendation and payment of the prescribed fee is required.
10. A student is allowed a **maximum of two re-admissions** during their course of study. After that, they will **cease to be a student** of the college.

D. General Rules

1. Even if a student earns a prize based on University Examination results, this prize will not be awarded if they do not appear in the House Examination. However, this condition will be relaxed for a student who represents the college in inter-college/University/State/National competitions, provided the concerned student has sought prior permission from the Principal.

2. A prize for a merit position will be awarded only if the student secures a minimum of 55% marks in aggregate and passes in all subjects.

22. Rules for Inter-College Migration

Migration to and from another college is governed by the Himachal Pradesh University (HPU) rules. A migrated student must bring the following documents:

- Migration certificate issued by the university.
- Character certificate from the Principal of the college last attended.
- Lecture attendance statement.

After the migration has been sanctioned and notified by the University, the student must join the second college within the stipulated period, i.e., by the date specified by the university. The first college is entitled to the tuition fee for the month in which the university sanctions the migration.

The admission of a student migrating from another university will be treated as provisional and will be confirmed upon production of the migration certificate and a certificate of good conduct from the Head of the Institution last attended. However, a student disqualified by another university will not be granted admission during the period of disqualification.

23. Library Rules

The college has a fully computerized library with internet facility. It boasts a good collection of books and has different sections for textbooks and reference books. The library subscribes to 11 newspapers, numerous magazines, and 3 journals. Students are encouraged to utilize the library facility during working hours on all working days.

1. Students of all classes can borrow books from the college library.
2. Failure to return book(s) by the 16th day from the issue date will incur a fine of Rs. 1.00 per book per day.
3. If a book, after being issued to a student, is damaged or lost, the borrower (student) will be required to pay for the damage or loss.
4. Requests for the issue of reference books and current periodicals should not be made, as these are not issued. However, they may be read and consulted within the library.
5. The college identity-cum-library card must invariably be carried while visiting the library. This card should be kept carefully.

6. Loss of books should be immediately reported to the librarian in writing.
7. Students are advised to deposit their personal books etc. with the library attendant before approaching the librarian for reading.
8. The library is a sacred place. The college expects its students to observe silence and necessary discipline while they are in the library.

24. Identity Card

- A student without an identity card, duly signed by the Principal, is deemed an outsider.
- Without an identity card, no one is allowed to enter the college premises.
- Students should wear their identity card around their neck for easy visibility.
- In case the identity card is lost, a duplicate card will be issued only after an F.I.R. is registered with the nearest police station and an original copy of the FIR is appended with such a request.
- If a student is found not wearing their identity card around their neck, they will be fined Rs. 100/-.

25. Conduct Rules for Students (Do's and Don'ts)

To maintain a disciplined and academically conducive environment, the Principal and teaching staff have the authority to take disciplinary action against students involved in misconduct. Disciplinary action may include a fine, suspension, or expulsion.

Students are expected to follow these Do's and Don'ts:

Do's:

1. Show respect, courtesy, and politeness to teachers, college staff, and fellow students.
2. Maintain silence in the library and while moving through the college premises.
3. Attend classes regularly and be punctual.
4. Participate actively in academic and co-curricular activities.

Don'ts:

1. Do not engage in any form of **ragging** — it is strictly prohibited in and around the college campus.
2. Do not physically assault or abuse anyone; such acts will lead to **suspension, fine, expulsion**, and may be reported to the **police**.
3. Do not deface college property by writing on walls, blackboards, or desks.

4. Do not loiter aimlessly in the campus or corridors.
5. **Smoking is strictly prohibited** on the college premises and will be treated as an offence.

26. Anti-Ragging Policy

Ragging, both within and outside the college campus, including roads and approaches leading to it, is strictly prohibited. Ragging is a cognizable offense. If any student is found indulging in ragging, directly or indirectly, the college authorities are obliged under Rule 22, 17(a) to (d) of the Himachal Pradesh University Ordinance to expel the guilty student from the College.

Ragging includes any type of physical or mental torture inflicted by any individual or group, either through words or conduct, which creates an apprehension in the mind of a person that they cannot pursue their studies free from mental disturbance or torture. Any person who aids or abets such an action will be guilty of ragging. Any student convicted of an offense under this ordinance will be expelled from the institution and will not be admitted to any other educational institution for a period of three years from the date of the expulsion order.

All students admitted to the college are deemed to have given the following undertaking:

"I have gone through the rules and regulations regarding discipline of the University/college/institution, and I hereby solemnly affirm that I will not indulge in any act of ragging/indiscipline. I understand that if I am found guilty of such offenses as are covered under these rules, I will be liable for punishment as per UGC letter No. F-8-1/97 (C.P.P.-II) dated July 7, 2001, for implementation of the Supreme Court guidelines regarding curbing the menace of ragging in educational institutions."

27. Students' Facilities & Activities

1. College Students' Central Association (CSCA)

Formed as per the guidelines of Himachal Pradesh University, Shimla / Sardar Patel University, Mandi, the CSCA helps maintain discipline and involves students in various co-curricular activities such as seminars, cultural events, and intra/inter-college competitions.

2. College Magazine – “मणिमहेश”

Published once a year (subject to resource availability), the magazine provides a platform for students to express their creativity and develop writing skills.

3. Educational Tours

Depending on the availability of funds, the college organizes educational tours under faculty supervision to places of educational, historical, cultural, or industrial significance. Only students with a **minimum of 75% attendance** and **at least 35% marks** in house examinations are eligible to participate.

4. Parent-Teacher Association (PTA)

The PTA plays a key role in the development of the college by contributing to infrastructure improvement and supporting student welfare activities.

5. National Service Scheme (NSS)

The College runs a half-unit of NSS (since 10/10/2006) under HPU's advisory committee. The unit can enroll **50 student volunteers** annually.

29. Student Support Cells

- 1.
